As of right now, there will be multi events at the regional meet (the world still is a bit fluid - but I don't see it changing by July). Athletes who want to compete in the multi event at the region meet will be able to. It will be open to all.

A couple of other questions have come up over the past couple of days.......

Q: Since the Association and Region 8 meet are both "open" do athletes have to enter the same events at both meets? A: No, they can enter the events they want at both meets, as long as the events are for their division and they do not go over the max.

Q: Are the multi events taking the top 48 at the National meet?

A: No. The wording is pretty vague, but they will take the top 2 from the region meet and anyone who meets a certain score. (At this time, I do not know what the scores are)

Q: Do athletes still need a negative COVID test or proof of vaccination before attending the National meet? A: As of today, Yes. USATF Youth Committee will be following the USATF Covid protocols. Next week could be a very different story.

Q: What do I do if I can't get my membership in USATF Connect
